PERSONAL GUARANTY AGREEMENT

Instructions:

This Guaranty Agreement ("Guaranty") is for use in connection with the submission of an HP Business Credit Application by an applicant business for the extension of trade credit. A Guaranty may be requested in connection with a Business Credit Application based on the availability of credit information, financial condition of applicant's business, or other information obtained in the credit investigation of applicant, and is **required for all Business Credit Applications submitted by applicants in business for 1 years or less requesting credit in excess of \$10,000**. [In order to be eligible as a guarantor, an individual must own at least 25% of the applicant business.]

Section H - TERMS AND CONDITIONS OF GUARANTY:

THIS GUARANTY IS GIVEN AND MADE BY THE ABOVE NAMED INDIVIDUAL (HEREINAFTER "GUARANTOR") IN CONSIDERATION OF CREDIT BEING EXTENDED PACKARD COMPANY (HEREINAFTER "HP"), HFWI FTT TO (insert legal company (HEREINAFTER "APPLICANT") FOR MERCHANDISE TO BE PURCHASED WHETHER APPLICANT IS A PROPRIETORSHIP, A PARTNERSHIP, A CORPORATION, OR OTHER ENTITY. GUARANTOR HEREBY CONTRACTS AND AGREES TO HP THE FAITHFUL PAYMENT WHEN DUE, OF ALL ACCOUNTS OF SAID APPLICANT. GUARANTOR HEREBY EXPRESSLY WAIVES ALL NOTICE OF ACCEPTANCE OF THIS GUARANTY, NOTICE OF EXTENSION OF CREDIT TO APPLICANT, PRESENTMENT, AND DEMAND FOR PAYMENT ON APPLICANT, PROTEST AND NOTICE TO GUARANTOR OF DISHONOR OR DEFAULT BY APPLICANT OR WITH RESPECT TO ANY SECURITY HELD BY HP, EXTENSION OF TIME OF PAYMENT TO APPLICANT, ACCEPTANCE OF PARTIAL PAYMENT OF PARTIAL COMPROMISE, CHANGES TO THE PAYMENT TERMS OF APPLICANT, ALL OTHER NOTICES TO WHICH THE GUARANTOR MIGHT OTHERWISE BE ENTITLED AND DEMAND FOR PAYMENT UNDER THIS GUARANTY.

ANY REVOCATION OF THIS GUARANTY SHALL BE IN WRITING AND DELIVERED TO CREDIT MANAGER, HEWLETT PACKARD COMPANY, 301 S. ROCKRIMMON BLVD, COLORADO SPRINGS, CO. 80919. ANY SUCH REVOCATION SHALL BE EFFECTIVE AS TO ANY EXTENSION OF CREDIT MADE THREE OR MORE BUSINESS DAYS AFTER RECEIPT BY HP OF SUCH NOTICE OF REVOCATION. IN THE EVENT THERE ARE MULTIPLE GUARANTORS WITH RESPECT TO ANY ACCOUNT OF APPLICANT, GUARANTOR AGREES TO BE JOINTLY AND SEVERALLY LIABLE UNDER THE TERMS OF THIS GUARANTY. GUARANTOR AUTHORIZES HP TO INVESTIGATE HIS OR HER BUSINESS AND PERSONAL CREDIT WORTHINESS AND TO ORDER A CONSUMER CREDIT REPORT FOR THE PURPOSES OF PROVIDING TRADE CREDIT TO APPLICANT. GUARANTOR AGREES THAT ANY NEGATIVE INFORMATION INCLUDING ANY FAILURE TO MAKE REQUIRED PAYMENTS HEREUNDER MAY BE REPORTED TO CREDIT REPORTING AGENCIES. IN THE EVENT APPLICANT'S ACCOUNT OR THIS GUARANTY AGREEMENT IS PLACED IN THE HANDS OF A COLLECTION AGENCY OR ATTORNEY FOR COLLECTION OR SUIT IS INSTITUTED TO COLLECT SAME, OR ANY PORTION THEREOF, GUARANTOR AGREES AND PROMISES TO PAY REASONABLE COLLECTION AND ATTORNEY FEES.

GUARANTOR WAIVES THE RIGHT TO REQUIRE HP TO PROCEED AGAINST APPLICANT OR ANY OTHER PERSON OR ENTITY, TO PROCEED AGAINST OR EXHAUST ANY SECURITY HELD FROM APPLICANT, OR TO PURSUE ANY OTHER REMEDY. GUARANTOR FURTHER WAIVES ANY DEFENSE BASED ON STATUTES OF LIMITATIONS OR DELAY IN ENFORCEMENT OF HP'S RIGHTS, TO THE EXTENT PERMITTED BY LAW AND ANY DEFENSE BASED ON DISCHARGE OR LIMITATION OF APPLICANT'S LIABILITY.

GUARANTOR AGREES TO KEEP HP INFORMED OF APPLICANT'S FINANCIAL CONDITION AND ALL OTHER CIRCUMSTANCES BEARING UPON THE RISK OF NONPAYMENT ON ANY ACCOUNT OF APPLICANT. GUARANTOR HEREBY SUBORDINATES THE PRESENT AND FUTURE INDEBTEDNESS OF APPLICANT TO GUARANTOR IN FAVOR OF ANY INDEBTEDNESS OF APPLICANT TO HP.

THIS GUARANTY SHALL BE GOVERNED AND CONSTRUED IN ACCORDANCE WITH THE LAWS OF THE STATE OF CALIFORNIA WITHOUT REGARD TO CONFLICT OF LAWS PRINCIPLES. VENUE FOR ANY LEGAL ACTION IN CONNECTION WITH THIS GUARANTY SHALL BE THE STATE OF CALIFORNIA, COUNTY OF SANTA CLARA.

THIS GUARANTY CONSTITUTES THE ENTIRE UNDERSTANDING OF THE PARTIES WITH RESPECT TO THE SUBJECT MATTER HEREOF, AND SHALL BE MODIFIED ONLY BY A WRITTEN AGREEMENT SIGNED BY THE PARTIES. THIS GUARANTY SHALL BIND AND BENEFIT THE SUCCESSORS AND ASSIGNS OF THE PARTIES.
